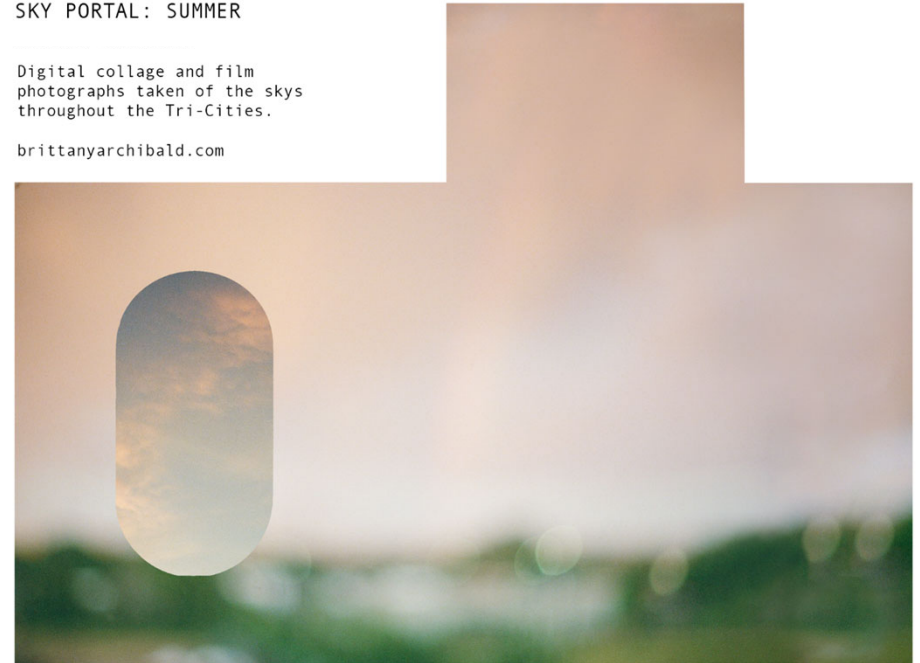

No color palette nor designs of the people have been set, any suggestions would be appreciated.



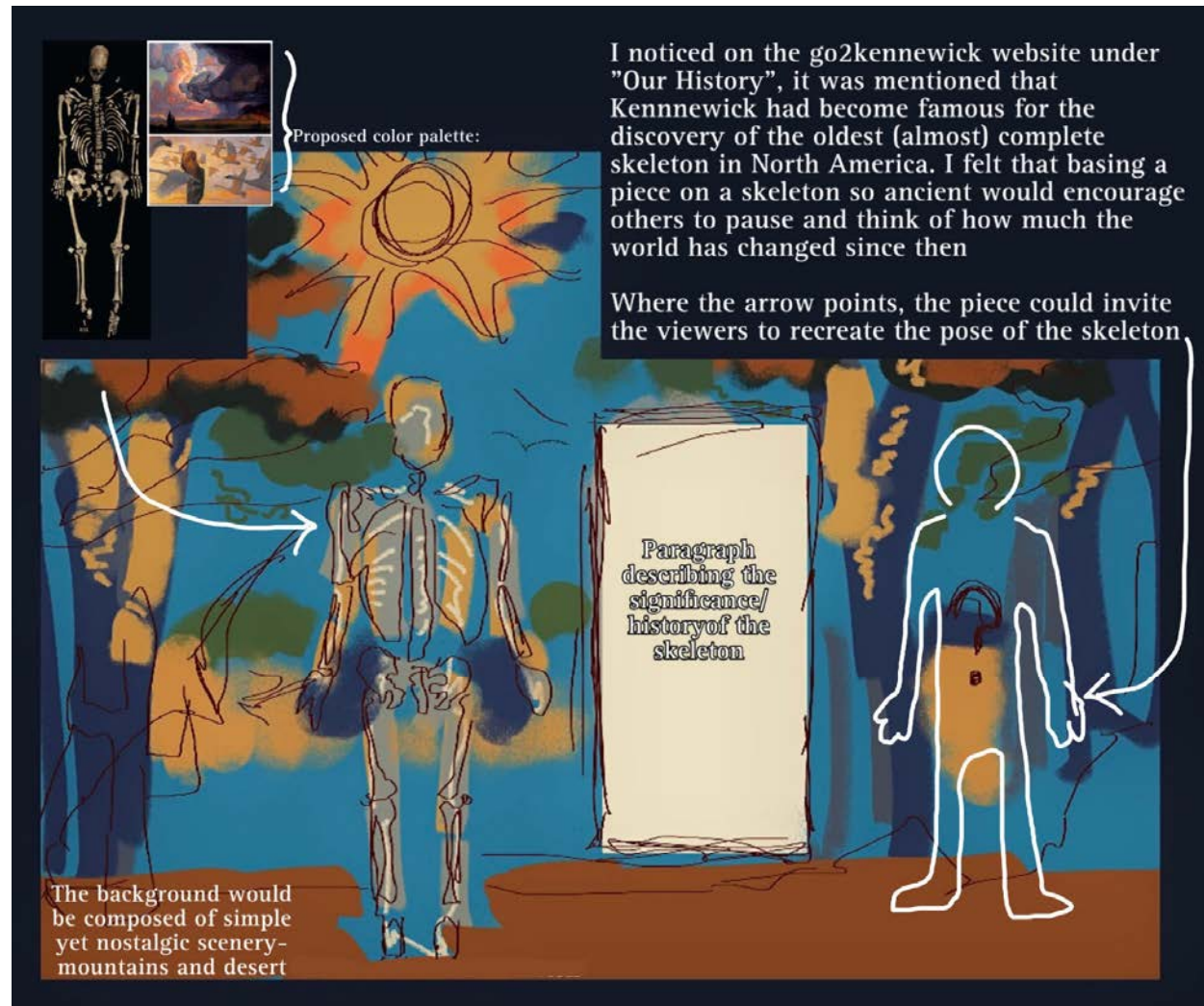
