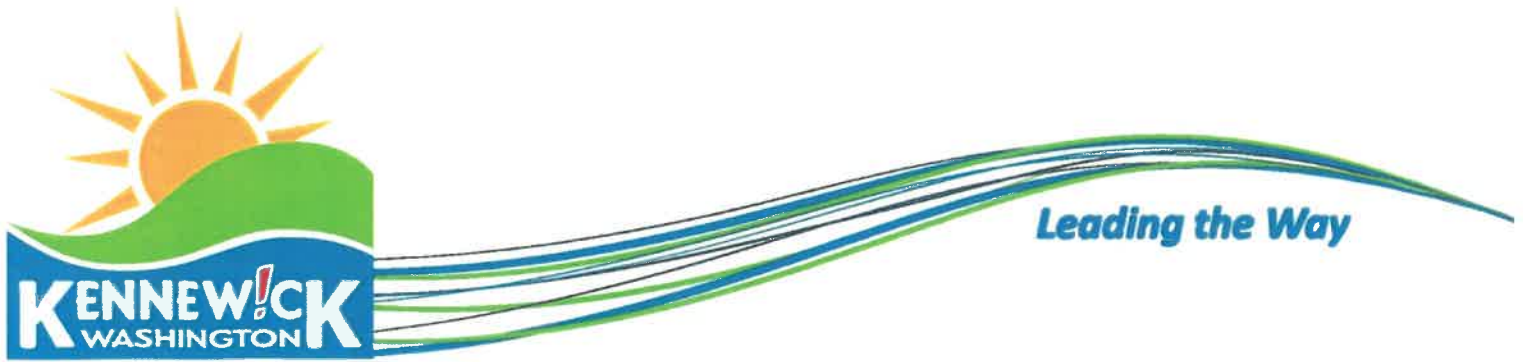

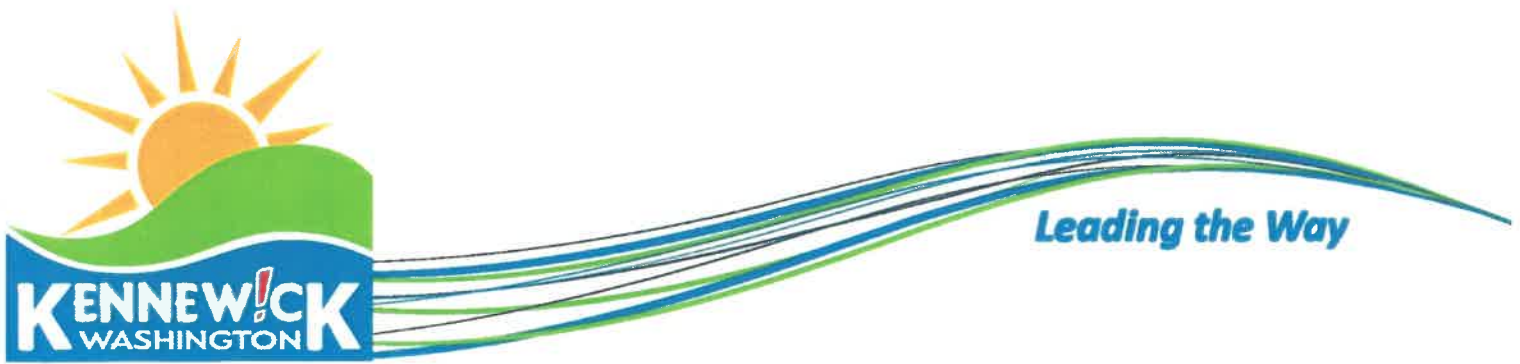

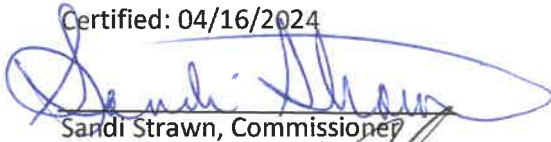
ii. Fire Department
