RE: Hydrocodone Prescription Payment Denial

Dear Board Members;

On November 19th I underwent my 3rd back surgery at Apex Spine in Richland and was advised, by my physician that he would be taking over my needs for pain meds during recovery. I have been in chronic pain from back problems/injuries for the past several years and prescribed hydrocodone to control the pain. I currently see a PA named Dennis Eng (also with Apex Spine) for pain management but as noted, my surgical physician, Dr. Sahota (or his staff) took over this management temporarily after my surgery. Due to added pain from surgery, Dr. Sahota's prescribed amount of medication exceeded my current prescription and without additional medication, I would have run out.

When I went to get the prescription filled, our insurance company, in their infinite wisdom informed the pharmacy they wouldn't cover the expense of the additional medication because it exceeded their "limitations" and, regardless of what the doctor prescribed, they wouldn't cover the \$77.77 cost, forcing me to pay out of pocket for the medication.

I am enclosing the receipt for the medication along with a printout from the pharmacy reflecting the denial of our insurance to cover the cost. I would appreciate the board reviewing this material for reimbursement.
