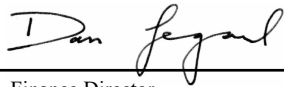

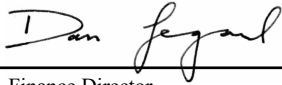

Motion for Consideration

I move to authorize the Mayor to sign a Memorandum of Agreement with Jacobs RR, LLC, to exchange surplus Steptoe Street right-of-way for utility and public access easements.

Summary

The City has an existing sewer line across Mr. Jacobs' property without an easement. This same area coincides with a proposed future pedestrian and bicycle pathway extension. There is a current well-used public pathway (the Keene Road Trail) on the west side of Steptoe Street that extends more than seven miles to the west. The City has future plans to extend this pathway east of Steptoe Street along former railroad right-of-way to the area of the Columbia Center Mall, and the opportunity to preserve a route for this pathway is now, before this property is developed.

The City also has surplus right-of-way behind the sidewalk along Mr. Jacobs' Steptoe Street frontage. Steptoe Street is fully built out today as a five-lane street with curb, gutter and sidewalk, so this extra right-of-way is not needed. This extra area would allow for more frontage setback and landscaping for Mr. Jacobs to develop his property.

It is beneficial to both the City and Mr. Jacobs to exchange surplus right-of-way for needed easements. A Memorandum of Agreement has been negotiated with assistance from the City Attorney, and staff recommends that this agreement is executed and enacted.

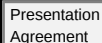
Once the MOA is approved, the City will move forward with setting a public hearing for the vacation of the surplus right-of-way. Once the right-of-way is vacated, all easements will then be recorded.

MEMORANDUM OF AGREEMENT
BETWEEN
THE CITY OF KENNEWICK
AND
JACOBS RR, LLC

THIS AGREEMENT is made and entered into this ____ day of January, 2020, by and between the CITY OF KENNEWICK (hereinafter referred to as "City"), a Washington municipal corporation and JACOBS RR, LLC, a limited liability company (hereinafter referred to as "Developer")

I. RECITALS

WHEREAS, Developer owns an undeveloped parcel of land along the east side of N. Steptoe Street, addressed as 2062 N. Steptoe Street and denoted by Tax Parcel No. 1-3099-300-0010-001; and

WHEREAS, City owns right-of-way behind the sidewalk along the east side of N. Steptoe Street, adjacent to Developer's land known as 2062 N. Steptoe Street; and

WHEREAS, Developer desires to obtain additional land along its N. Steptoe Street frontage for future landscaping and setback purposes; and

WHEREAS, City has an existing sanitary sewer facility on Developer's land near the south property line that does not have a formal easement; and

WHEREAS, City desires to extend a regional pathway for pedestrians and bicycles across Developer's land in the future; and

WHEREAS, there are mutual benefits to City and Developer to enter into this memorandum of agreement; and

WHEREAS, the purpose of this Memorandum of Agreement is to set forth the responsibilities of each party;

NOW THEREFORE, for and in consideration of the covenants contained herein, performed and to be performed, the parties hereto agree as follows:

II. TERMS

Section 1. The City agrees to perform the following:

- A. City will vacate all right-of-way to the Developer lying easterly of the existing east sidewalk of N. Steptoe Road that fronts Developer's land. This encompasses 2,735 square feet, as shown in **Exhibit A**. This vacation will be initiated by the City no later than 30 days following the execution of this agreement and receipt of executed easements described in Section 2A and 2B.

Section 2. The Developer agrees to perform the following:

- A. Developer will grant to the City a fifteen (15) foot wide utility and public access easement over the south 15 feet of its land, as shown in **Exhibit B**. Said easement shall provide that there shall be no setback requirement related to the easement and Developer may construct improvements up to the edge of the easement and further provided said easement shall specifically permit use or crossing of the easement area for other utilities serving the Developer's parcel so long as other utility uses do not interfere with the City's utilities or pedestrian and bicycle path within the easement area.
- B. The Developer shall grant to the City a utility easement over the west five (5) feet of its land (as located after vacation is completed), as shown on **Exhibit B**. The easement document shall specifically permit crossing of the easement for vehicular access to Developer's property at a location to be agreed upon during any permitting process, and shall also recite that other utilities needed for development of Developer's property may utilize the easement area so long as such utilities do not interfere with the City's utilities in the easement area.

Section 3. The City and Developer agree that the easements described in Section 2.A and 2.B shall be executed by the Developer prior to the City initiating the vacation process described in Section 1.A, and said easements shall not be recorded until after the right-of-way has been vacated as described in Section 1.A. If the right-of-way vacation is not approved, the easements shall be null and void and its terms shall so provide.

Section 4. The Developer shall not be required to contribute to the cost of constructing any improvements within either easement area, whether or not such construction occurs before or after development of Developer's property, with the exception of construction of utilities and access to specifically serve the Developer. Further, Developer shall have no maintenance responsibilities whatsoever in connection with improvements made within the easement areas by the City as contemplated by this Agreement.

Section 5. City and Developer agree that the terms of this agreement represent a fair and equitable balance of consideration for each party. The City shall be responsible to develop the agreement, including associated legal descriptions and exhibits, and to pay the recording costs. Surveys or site work related to future public utility and pathway improvements contemplated by this Agreement shall also be paid for by the City.

Section 6. Notices under this Agreement shall be in writing and may be delivered (a) personally; (b) by U.S. Mail; (c) email or facsimile, directed to the other party at their address set forth below:

Section 7. Dispute Resolution.

The City and the Developer agree to negotiate, in good faith, for a period of thirty (30) days from the date of notice of all disputes between them prior to exercising their rights under this Agreement, or under law. All disputes between the City and the Developer not resolved by negotiation between the parties may be arbitrated only by mutual agreement of the City and the Developer. If not mutually agreed to resolve the claim by arbitration, the claim will be resolved by legal action. Arbitration of all claims will be in accordance with the Arbitration Rules of the American Arbitration Association, unless otherwise agreed.

Section 8. Jurisdiction and Venue

In the event that either party deems it necessary to institute legal action or proceedings to enforce any right or obligation under this Agreement, the parties hereto agree that any such action shall be initiated in the Superior Court of the State of Washington, situated in Benton County. The parties hereto agree that all questions shall be resolved by application of Washington law and that the parties to such action shall have the right of appeal from such decision of the Superior Court in accordance with the laws of the State of Washington. The Developer hereby consents to the personal jurisdiction of the Superior Court of the State of Washington, situated in Benton County.

Section 9. Indemnification/Hold Harmless

Developer shall defend, indemnify and hold the City, its officers, officials, employees and volunteers harmless from any and all claims, injuries, damages, losses or suits including attorney fees, arising out of or in connection with Developer's negligence in the construction of its access and providing for utilities to Developer's property. The City shall defend, indemnify and hold the Developer, its officers, employees and volunteers harmless from any and all claims, injuries, damages, losses or suits including attorney fees, arising out of or in connection with the performance of this Agreement, except for injuries and damages caused by the sole negligence of the Developer. The City's indemnity and hold harmless obligation shall specifically extend to any alleged liability of Developer, or its successors in interest, related to design or use of the pedestrian and bicycle path and easement over the south 15' of Developer's property, including attorney fees, unless such liability arises out of Developer or successor's actual negligence or intentional acts.

Section 10. The City shall reimburse Developer one-half of its attorney review costs and expenses, up to a maximum of \$2,000 in connection with this Agreement.

Section 11. The benefits and burdens of this Agreement shall run with the land and be binding upon the successors and assigns of the parties.

Section 12. This Agreement supersedes all prior agreements and understandings whether written or oral between the Parties with respect to the subject matter hereof.

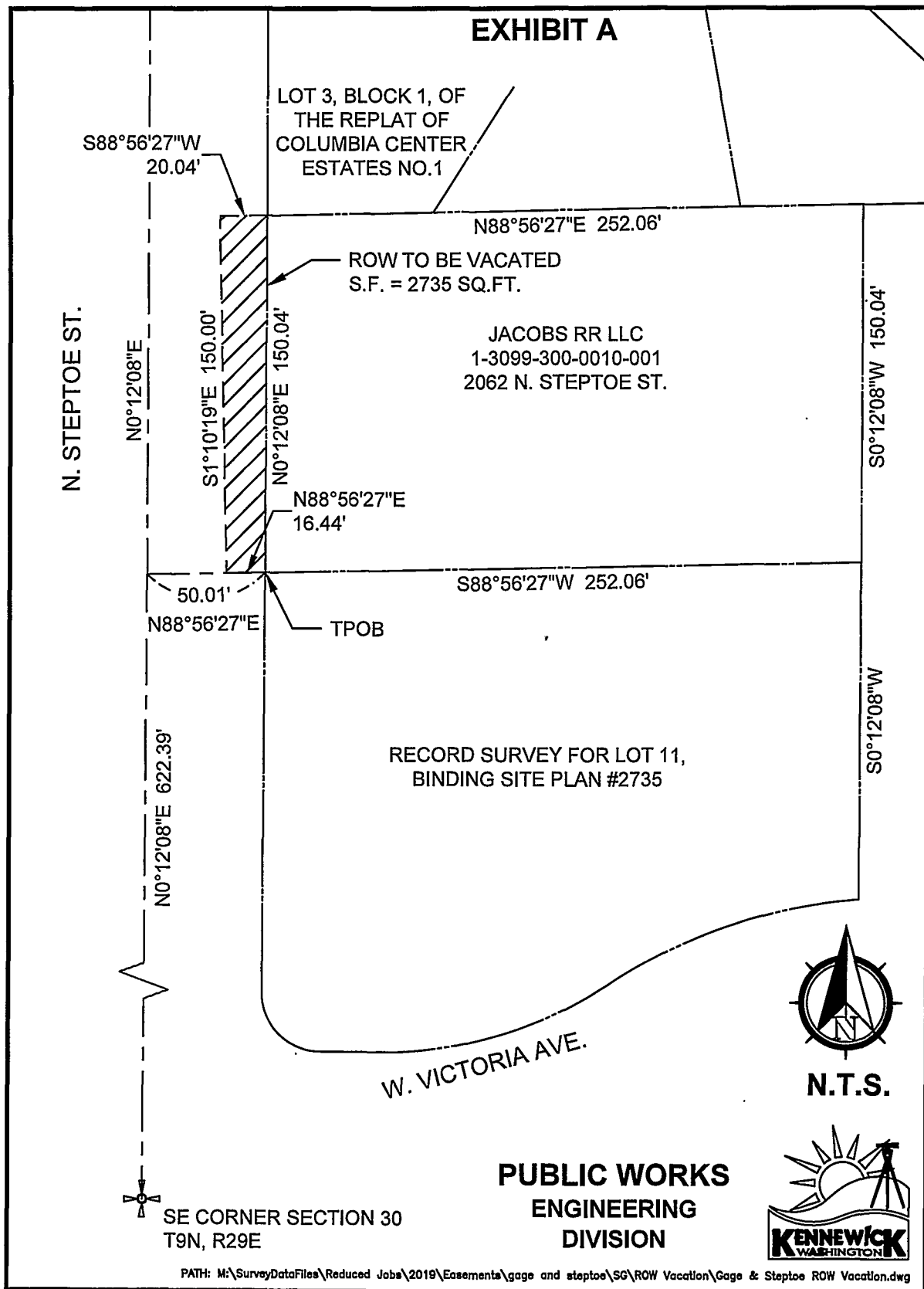

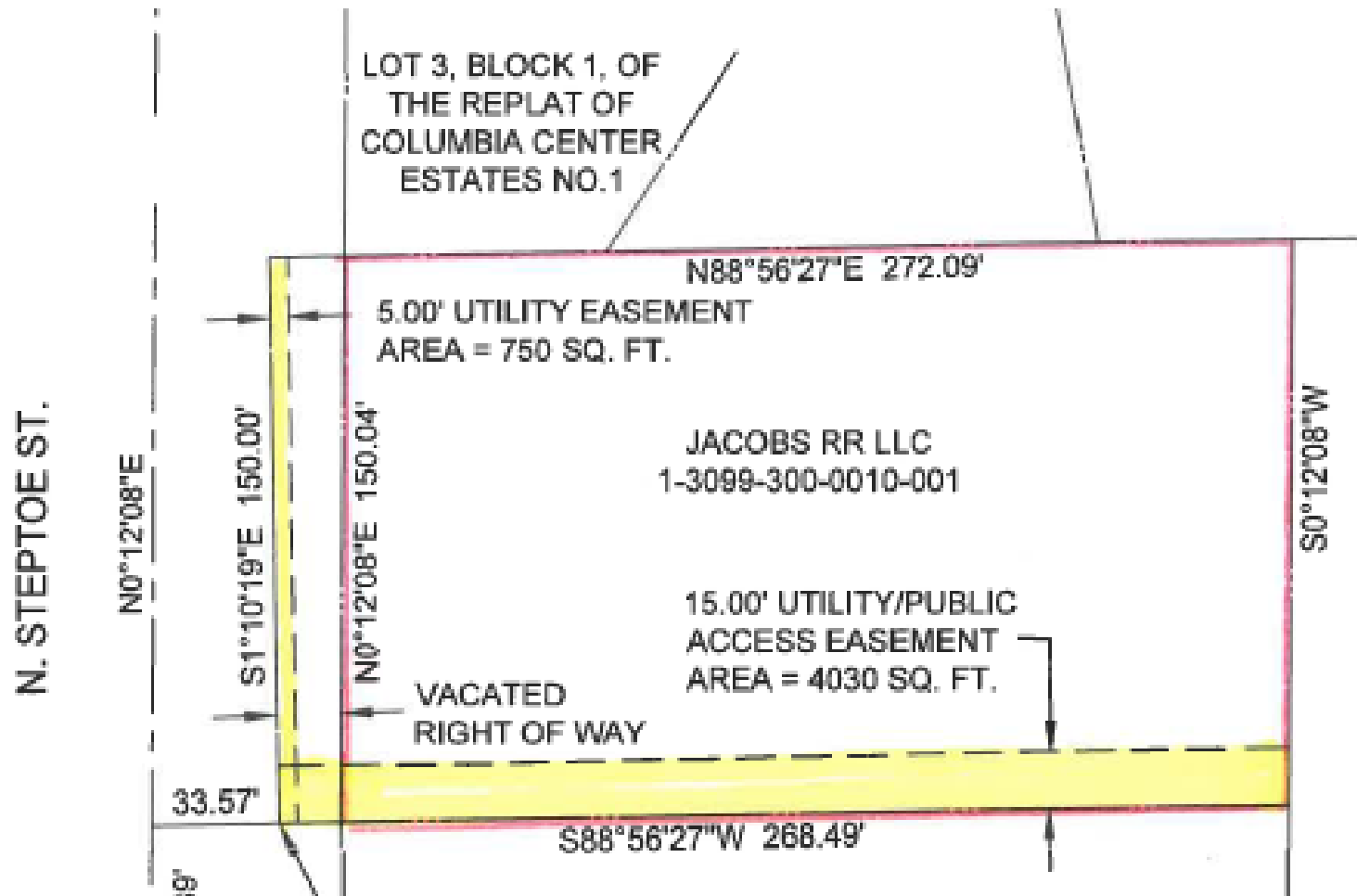
