1. **UPDATE: CONVENTION CENTER & KENNEWICK PUBLIC FACILITIES DISTRICT (PROJECT TOUR):** Councilmembers, staff, visitors, and members of the media toured the Three Rivers Convention Center expansion construction site, returning to the meeting room at 4:34 p.m. No action taken.
2. **INTERLOCAL AGREEMENT: PARKING LOT E AT THE THREE RIVERS CONVENTION CENTER BETWEEN THE CITY OF KENNEWICK, THE PORT OF KENNEWICK, AND THE KENNEWICK PUBLIC FACILITIES DISTRICT:** Ms. Erdman gave a brief update and noted that due to the review process by the Port, the February 17, 2026, City Council agenda meeting materials would be published later in the week than typical. No action taken.

Ms. Erdman provided Councilmembers with a working copy of the joint resolution with the school district concerning LRA facilities which will be considered by Council on February 17. She briefly mentioned she was sharing the draft resolution now to ensure that Councilmembers had enough time to review it, given the anticipated late agenda packet distribution this week. The content of the resolution was not reviewed or debated. No action taken.
